

# **Opioid Prescribing**

In October 2018, the Oregon Health Authority released the <u>Oregon Acute Opioid Prescribing Guidelines</u>. These guidelines are applicable to **all medical and dental providers** who prescribe opioids for the management of acute pain.

### The guidelines recommend:

- Evaluation of the patient to identify cause and type of pain, determine period for recovery, assess age and other medical conditions, and review current medication list. The results of the evaluation and justification for prescription of an opioid must be documented in the patient record.
- Assess history of long-term opioid use and/or substance use disorder. Make sure to coordinate
  with other providers who have prescribed a controlled substance to the patient. Don't forget to
  assess the patient's use of alcohol or sedative medications, which may exacerbate the sedative
  effects of opioids.
- Check the Prescription Drug Monitoring Program database.
- Provide patient education including: expected type and duration of pain, risks and side effects of opioids, and how to ensure controlled medications are not diverted.
